



Coaches Rules of Conduct

1. I will not force an unwilling child to participate.
2. I will teach my players that giving an honest effort is more important than victory.
3. I will remember that children learn best by example. I will applaud good plays by our team and by the opposing team. I will also exhibit good overall sportsmanship at all times.
4. I will at all times abide by the rules and regulations of the SRA and guidelines governing the sport being played.
5. I will require my players to play by the rules and regulations of the SRA and guidelines governing the sport being played.
6. I will never ridicule nor verbally attack a player for making a mistake or playing poorly during a game or practice.
7. I will at no time publicly question an official's honesty, argue excessively or publicly berate an official for any call made during the course of a game.
8. I will at all times refrain from verbal and physical abuse of all players, coaches, game officials, parents, spectators and league representatives at all SRA and other tournament events. In addition, I will support all efforts to remove verbal and physical abuse from youth sports.
9. If a head coach asks for timeout to discuss a rule or call, both head coaches must be present for the discussion. **No exceptions.** Both coaches must meet the umpire(s) on the field and do not engage the umpire until the opposing head coach is involved in the discussion.
10. I will at no time physically or verbally confront any player, coach, game official, parent spectator or league representative about any matter related to an SRA event or program.
11. I will bring any issues about the rules, officiating or opposing coaches to the attention of the respective SRA representative.
12. I will recognize the value and importance of players' parents/guardians. If I am dissatisfied with specific behavior, I will talk to the parent/guardian privately.
13. I will strive to support my players' involvement in sports and to maintain a realistic expectation about their effort and performance.
14. I will remember that I am a youth sports coach and that the game is for the children, **NOT** the adults.
15. If ejected from a game, I acknowledge that I will serve a minimum of a one game suspension following that game.



16. If ejected from a second game, I acknowledge that I will be suspended for the remainder of the season and may not be allowed to coach an SRA team in the future.
17. I agree not to use Alcohol, Tobacco, Cigarettes or e-Cigs, Smokeless/Chewing Tobacco or any “tobacco” or perceived tobacco products at any SRA related event, on or near the fields or any facility that is tobacco free or alcohol free. This is a zero-tolerance policy. Any occurrences at or during an SRA related event or facility will result in removal as a coach and any addition position held with the SRA including board member, commissioner, or assistant to anyone on the board.

Violation of the Coaches Rules of Conduct can result in suspension depending on severity of circumstances and judgment of the SRA Board of Directors. Don't make your team suffer due to poor conduct on your part!
